- Notice is given to qualified persons residing within Brigham City, Deweyville Town, Elwood Town, Garland City, Honeyville City, Howell Town, Mantua Town, Plymouth Town, Perry City, Snowville Town, Tremonton City, and Willard City that the Municipal General Election is to be held Tuesday November 4, 2025 from 7:00 am-8:00 pm.

U.S. Citizen, resident of the State of Utah for over 30 days preceding election, 18 years of age by November 4, 2025 and registered to vote in the municipality.

- Notice is given of the election audit required by the Lieutenant Governor's Election Policy. The audit will be conducted during normal business hours in the Box Elder County Courthouse 1 South Main Suite #10, Brigham City, Utah beginning Monday November 10, 2025 at 2:00 pm and continuing until completed. Anyone desiring to witness the audit is invited to attend.

Certification of Ballot Counting Equipment

- Box Elder County will publicly conduct a logic and accuracy test and demonstration of the automatic tabulating equipment that will be used to count the ballots for the General Election. The demonstration and test will be conducted October 15, 2025 at 9:00 a.m. in room #10 of the County Courthouse 01 South Main Street Brigham City, Utah. The test and demonstration is open to the public in accordance with Utah Code 20A-4-104 and 20A-3-201.
